The Chief and Council is also responsible for recommending the appointment of the Nation's external accountants.



We have reviewed the schedule of remuneration and expenses - Chief and Councillors of Fort Alexander Indian Band for the year ended March 31, 2024.

Management's Responsibility

Management is responsible for the preparation and presentation of this schedule in accordance with First Nations Financial Transparency Act, and for such internal control as management determines is necessary to enable the preparation of the schedule that are free from material misstatement, whether due to fraud or error.

Practitioner's Responsibility

Our responsibility is to express a conclusion on the accompanying schedule based on our review. We conducted our review in accordance with the Canadian generally accepted standards for review engagements, which require us to comply with relevant ethical requirements.

A review of the schedule in accordance with Canadian generally accepted standards for review engagements is a limited assurance egagement. The practitioner procedures, primarily consisting of making inquiries of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

Basis of Accounting

Without modifying our conclusion, we draw attention to the fact that the schedule is prepared to assist the Nation to meet the requirements the First Nations Financial Transparency Act Reporting Requirements. As a result, the schedule may not be suitable for another purpose.
