I hereby agree that, upon my receipt of the Payment consistent with these instructions, I grant to Sagkeeng Anicinabe First Nation and Royal Trust Corporation of Canada a full, final and complete discharge with respect to the payment and release Sagkeeng Anicinabe First Nation and Royal Trust Corporation of Canada from any further obligation to account to me or make a distribution to me in connection with the Payment.

I hereby agree to indemnify Sagkeeng Anicinabe First Nation and Royal Trust Corporation of Canada, including the directors, officers, employees, and agents of Royal Trust Corporation of Canada (collectively the "Indemnified Parties"), and save them harmless from any and all liability, losses, damages, costs (judicial or not), charges and other expenses of any kind or nature arising at any time directly or

indirectly out of or in consequence of any action, proceeding, account, claim or demand which may be imposed upon, or incurred by, any one or more of the Indemnified Parties in relation to the making of the Payment out of the Trust to me and Royal Trust acting upon the payment instructions contained herein.

17. I hereby acknowledge that I have had the opportunity to seek independent legal advice with respect to my execution of this Payment Instruction, Release, Discharge and Indemnity and confirm that I have either done so or have chosen of my own free will not to do so.

18. I am executing this Payment Instruction, Release, Discharge, and Indemnity under seal and intend to adopt the pre-printed mark contained by my signature as my seal so as to bind myself to the terms of this Payment Instruction, Release, Discharge, and Indemnity.

19. Any part, provision, term or declaration of this Payment Instruction, Release, Discharge and Indemnity which is prohibited, or which is held to be void or unenforceable shall be ineffective to the extent of such prohibition or unenforceability without invalidating the remaining parts, provisions, terms or declarations hereof.

20. I agree that (i) this Payment Instruction, Release, Discharge, and Indemnity may be delivered electronically and that I am immediately and unconditionally bound upon such electronic delivery, and (ii) that a faxed, scanned, or otherwise electronically delivered copy of this executed Deed shall be deemed to be an original.

Steps required to receive the Per Capita Distribution Payment from the Treaty Land Entitlement Claim

1. Ensure you have a **Bank Account** with a financial institution.
2. Execute the **Payment Instruction, Discharge, Release and Indemnity Form** and have it witnessed which must be completed in full before your PCD payment can be made. You are also required to provide the Band Office with a **copy of a void cheque or account verification document** issued from your financial institution that will have all your account details.
3. Please forward to the Band Office, as follows:
 - a) In person at the Sagkeeng Anicinabe Government Office
 - b) By mail to P.O. Box 3, Fort Alexander, MB R0E 0P0
 - c) By email to TLEApplication@sagkeeng.ca
4. Once your form has been verified to be complete it will be forwarded to Royal Trust to enter into the system. When Settlement funds have been received, Royal Trust will wire funds directly to your Bank Account (once the transfer has been completed please note it will take from one to three business days to reach your account).
5. If you are in the US make sure you include wire transfer information.
